

**THE CORPORATION OF THE TOWNSHIP OF OPASATIKA  
BY-LAW NO 2022-06**

Being a By-Law to establish a water service rate.

WHEREAS Section 8 of the Public Utilities Act, Chapter P.52, R.S.O. 1990, as amended, authorizes a municipality to establish a water service rate.

NOW THEREFORE, the Council of the Corporation of the Township of Opatatika ENACTS AS FOLLOWS:

1. A water service rate is hereby imposed upon the owners or occupants of lands which are supplied with water service by the Corporation of the Township of Opatatika.
2. The water service rate shall be as set out in the attached 'Schedule A'.
3. The water service rate shall be charged as a flat rate from January 1 to December 31, 2022.
4. The water service rate shall become due and payable in one installment as per the interim tax bills and another two installments as per the final tax bills.
5. On all water service rates in default after due dates, a monthly penalty of 1.25 percent shall be added on the 1st day of each and every month, the default continues until December 31, 2022.
6. On all water service rates in default on January 1, 2022, interest will be charged at the rate of 1.25 percent per month in which default continues.
7. This by-law repeals by-law 2021-07.
